## Rules

1. All cattle must be registered.
2. All entries must be paid in full by the deadline date.
3. No changes or substitutions of cattle once entered.
4. A non-refundable fee of \$250 must accompany all protests.
5. Decisions of the judges will be final.
6. Anyone who is proven to have cheated on genetics or age will be banned from future ITTLA events.
7. All futurity cattle MUST have health certificate with a veterinary visual inspection.
8. Hay and water will be provided for futurity entries.
9. Entries must be postmarked by May 6, 2016.

### FUTURITY WINNERS

All 10 futurity winners will be allowed to sell in the **Red River Longhorn Sale** on Saturday May 28, 2016 if you so desire. However, if you think your animal will win its class and will be entered into the sale, that animal must meet all health certificate requirements listed in the Red River Longhorn Sale Consignment Rules. This includes Brucellosis (Bangs) and Tuberculosis test results listed on their health certificate. Since futurity entries not entered in the sale only require a health certificate with a veterinary visual inspection, please plan accordingly and get this additional testing done when you get your health certificate if you think you will enter a futurity winner in the sale. See the Red River Longhorn Sale Consignment Rules for more information on their requirements.

If you choose to enter your futurity winner in the sale, you will not be required to pay the consignment fee, however the 7% commission will apply.
